We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., (Not For Profit). Providing for the formation, rights, privileges, immunities, and liabilities of incorporation for not for profit.

ARTICLE I

The name of the corporation should be:

HONDURAS SOCCER LEAGUE OF FLORIDA, INC.

ARTICLE II

The purpose for which the corporation is organized is to promote sports among the community and provide the community with access to quality soccer facilities, coaching and competition at different levels.

ARTICLE III

The corporation is organized and shall be operated on a non stock basis in compliance with the meaning of the Florida Non for Profit Corporation Act and shall not have the power to issue shares of any type of class or stock, but may issue membership certificates, if so provided in the By Laws.

The existence of the corporation is perpetual.

A quorum for the holding of a meeting of the board of directors and for the transactions of any business which will be properly done by the directors on behalf of the corporation shall consist of majority of members thereof; but the directors, by unanimous consent in writing, included among the minutes of the corporation, may consent to the doing of any act and such consent in writing shall have the same force and effect as though the said act had been done and authorized at a meeting at which a quorum had been present, or such duties may be delegated to an executive committee.

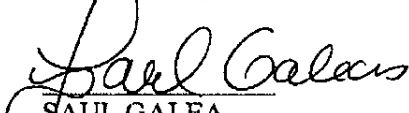
