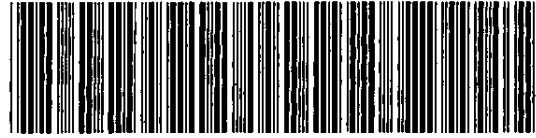

ARTICLE I-NAME

The purpose for which the corporation is organized is to support, publicize, research, teach, and proclaim the tenets of Jesus Christ and the Christian faith on a local, state, national, and international level through public and private meetings/conferences and the publishing/distribution of various media (print, digital, audio, video).

Tim Brannon Ministries will exercise any, all and every, power which an establishment of religion is entitled to fund, institute and/or organize national and/or international meetings or conferences and religious training centers, including churches, missions, and counseling centers.

This corporation is organized exclusively for charitable religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code

During the last quarter of each fiscal year of the corporation, the board of directors shall elect directors to replace those whose terms will expire at the end of the fiscal year. This election shall take place during a regular meeting of the directors, called in accordance with the provisions of the bylaws.




