CERTIFICATE OF INCORPORATION OF RUEL-ANN JOYFUL HOME, INC.

The undersigned acting as the incorporator of a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I: NAME

The name of the Corporation shall be RUEL.ANN JOYFUL HOME, INC., herein after referred to as "Corporation."

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSES

Notwithstanding any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, (or corresponding provisions of any future United States Internal Revenue Law), (ii) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Law).

ARTICLE V: RESTRICTIONS ON ACTIVITIES

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE VI: REGISTERED OFFICE AND AGENT

The Corporation's registered office shall be located at 3960 NW 32ND TERRACE LAUDERDALE LAKES, FL 33309 and Cynthia Bernard is the registered agent of the Corporation at that address.


