Certificate of Amendment

Families Against Murder and Accidental Shootings, Inc., a corporation of the State of Florida, whose registered office is located at 1730 N.W. 5th Avenue, Pompano Beach, Florida 33060, certifies pursuant to the provisions of the state law, that a meeting of the Board of said corporation call for the purpose of amending the articles of incorporation, and held on March 30, 2012, it was resolved by the vote of the Board of an appropriate majority of the members to note the following Article Amendments.

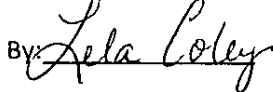
Article II of the Articles of Incorporation is amended to read as follows:

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This Corporation is set-up to generate money through the sale of a Specialty Tag, which will memorialize victims of murder in the State of Florida, children who kill themselves, their siblings or friends while playing with guns. All the proceeds generated from the sale of tags, acquired gifts/contributions shall be devoted to said purpose.

Article VI: Dissolution of the Articles of Incorporation is amended to read as follows:

Upon the dissolution of the organization, assets shall be distributed for one or more exempts purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax codes, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.
