ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:
D.R. LONG FOUNDATION, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

(1) To promote and further exclusively charitable, religious, educational and scientific purposes.
(2) To perform other activities permitted corporations under the General Laws of the State of Florida, to the extent such activities are permitted by organizations which are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provisions of any future United States Internal Revenue Law) and make contributions to which are deductible under sections 170(c)(2), 2055(a)(2) and 2522(a)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), including the making of distributions for charitable, religious, educational and scientific purposes to organizations which are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provisions of any future United States Internal Revenue Law) and contributions to which are deductible under sections 170(c)(2), 2055(a)(2) and 2522(a)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The number of directors on the Board of Directors shall be four (4), which number may be increased or decreased pursuant to the By-Laws of the Corporation, but shall never be less than the minimum number permitted by the General laws of the State of Florida, now or hereafter in force.

The Directors shall serve until the first annual meeting, and thereafter for three-year terms. All future vacancies shall be filled by appointment by the President.

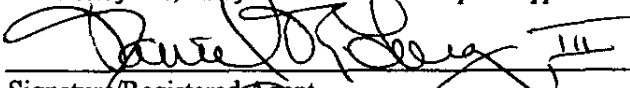

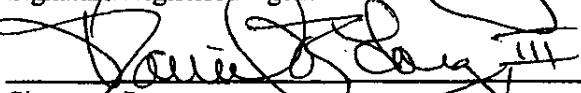
