Articles of Incorporation for Homeopaths Without Borders - North America, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a non-profit corporation under the Florida Not For Profit Corporation Act of 2009, Chapter 617 of the Florida Statutes, do hereby certify:

ARTICLE ONE

Identification

Section 1.01. Name. The name of the Corporation is "Homeopaths Without Borders - North America, Inc." The Corporation's principal place of business and mailing address is 601 McDonald Street, Unit 108, Mount Dora, Florida 32757.

ARTICLE TWO

Purpose and Powers

Section 2.01. Purpose. The specific purposes for which the Corporation is formed shall be to increase the access to homeopathic health care for all people, especially the poor and disadvantaged of the world; to provide homeopathy training and education, humanitarian aid and research. Additionally, the Corporation will act as an advisory source to the appropriate state government agencies in homeopathic matters; and facilitate public awareness and appreciation of the benefits of homeopathy.

Section 2.02. Powers. The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restrictions imposed by applicable law or these Articles.

Section 2.03. Purpose. Said Corporation is organized exclusively for educational purposes, within the meaning of §501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code), including for such purposes, the making of distributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

ARTICLE THREE

Registered Office and Registered Agent

Section 3.01. Registered Office and Agent. The name of the registered agent and the street address of the registered office of the Corporation are as follows:

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this incorporation, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.

ARTICLE FOUR

Directors

Section 4.01. Number and Qualification. The number of directors of the Corporation shall be specified, from time to time, by the Code of Bylaws, which number may be increased or decreased from time to time by amendment of the Bylaws. At no time shall there be less than three (3) Directors for the Corporation.

Section 4.02. Election of Directors. The initial Board of Directors has come together due to a mutual concern for health care, training, aid and research. Any vacancy subsequent to the initial Board of Directors shall be filled by appointment by the remaining Board of Directors.

Section 4.03. Conduct of Business. Directors may by the Corporation's By-Laws make any other provisions or requirements for the arrangement or conduct of the business of the Corporation, provided the same be not inconsistent with these articles of Incorporation nor contrary to the laws of the State of Florida or of the United States.

ARTICLE FIVE

Incorporator

Section 5.01. Name and Address. The name and address of the Incorporator of the Corporation is as follows:

ARTICLE SIX

Code of Bylaws; Indemnification; Amendments of Articles

Section 6.01. Code of Bylaws. The Board of Directors of the Corporation shall have the power to make, alter, amend, or repeal the Bylaws of the Corporation, subject to the restriction that a majority vote of the Directors is necessary to take these actions.

Section 6.02. Indemnification. The Corporation shall indemnify a director or officer of the Corporation who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the director or officer was a party because the director or officer is or was a director or officer of the Corporation, against reasonable expenses incurred by the director or officer in connection with the proceeding.

ARTICLE SEVEN

Limitations on Activities

Section 7.01. Limitations. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Two hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under §501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) a corporation, contributions to which are deductible under §170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE EIGHT

Dissolution

Section 8.01. Dissolution. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of §501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE NINE

Non-Stock

Section 9.01. Non-Stock Basis. This corporation shall be organized upon a non-stock basis.

ARTICLE TEN

Existence

Section 10.01. This corporation is to have perpetual existence.
