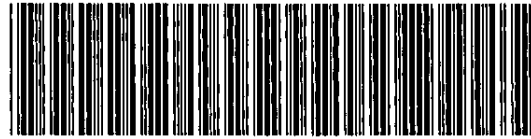

Amend Article 111 of the Articles of Incorporation, Specific purpose for which this corporation is organized, as follows:

JM Horse Rescue, Inc. (JMHR) is organized exclusively for the charitable purpose under section 501 (c)(3) of the Internal revenue Code, or corresponding section of any future federal tax code, for the prevention of cruelty to animals, specifically horses. JMHR will provide veterinary care and a good home for abused and neglected horses until they are physically well and adopted in a good home.

Add Article 1X to the Articles of Incorporation. Entitle the section Dissolution Clause, as follows:

Upon the dissolution of JM Horse Rescue, Inc. (JMHR), assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
