ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I. NAME

Congregación Mesiánica Sefardita Shomer Ysrael INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

1. To disseminate the Hebrew Roots of the Jewish Messianic Roots, to all the body of Messiah and to those interested to be confirmed to the image of the Jewish Messiah.
2. To assume our share of responsibility and privilege of propagating the message of the Hebrew Roots of the Messianic Judaism to all people regardless of race, social position, religion affiliation and political affiliation.

ARTICLE IV MANNER OF ELECTION

- We believe that the biblical system for the election of members to receive appointments is the congregational system.
- The Congregation will have a **Jewish Bet Din** (Board) for administrative purposes, **Elders**, to assist in the spiritual teaching and tasks and **Deacons** to serve the social work.
- The Bet Din will hold the Board position for a period of one year, and will have the opportunity to be reelected for a second term. In case of been reelected, the member cannot participate for a third term. In order to be appointed for another term as part of the Board, will have to allow one full term to pass, before considering being part of the Bet Din.
- The size of the Bet Din will be based on the Congregation's size. For a Congregation of 50 members, 3 Bet Din members. For a Congregation between 51 to 100 members, 5 Bet Din members will be required.
- Deacons and Elders ministry is considered a permanent position based on biblical foundation. These ministries require appointment by oil anointment, according to the Word of G-d.

ARTICLE VIII GENERAL OBJECTIVES

ARTICLE IX CRETERIAS FOR MEMBERSHIP

1. All people must take a course on Messianic Basic Principles before applying for membership.

3. The minimum age for membership is 13 years old after Bar Mitzvah.
4. People coming from other congregations, will have to wait 1 year in order to apply for membership. During that year, they must take the MBP (Messianic Basic Principles Course).

ARTICLE X TERM

This corporation shall exists perpetually or until dissolved by the due process of law. Should this corporation cease to exists as a legal entity and its charter be terminated, Title to all the property automatically shall become vested as fallow: Upon the dissolution the assets shall be distributed for one or more exempt purposes within de meaning of section 501 (c) (3) of the Internal Revenue code. Or corresponding section of any future tax code. Or shall be distributed to the Federal State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by court, of common pleas, of the county in which the principal office of the corporation is then located, exclusively for such purpose.

ARTICLE XI AMENDMENTS

The Bylaws can be amended only by the affirmative vote of two third of the members present in a duly convened and constituted Assembly.

ARTICLE XII ACCOUNTING

The closing month of the accounting year: December 31




