

ARTICLE I CORPORATE NAME

ARTICLE VI
LIABILITY OF DIRECTORS

To the fullest extent permitted by law, no director of this corporation shall be personally liable to the corporation or its members for monetary damages for breach of any duty owed to the corporation or its members, except that a director may be held personally liable for (i) breaches of the duty of loyalty, (ii) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of the law, (iii) declaration of unlawful dividends or redemptions as such are allowed by Florida law, or (iv) a transaction from which the director derives an improper personal benefit.

Any director or officer who is involved in litigation or other proceeding by reasons of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.

ARTICLE VII
OTHER PROVISIONS

Remaining Funds. Upon dissolution of the corporation, the final remaining funds in the corporate account will be used to better the community, at the discretion of the directors by a majority vote.


Corporate Seal. The corporation may, but is not required to have a corporate seal.


