Article III DURATION

The term of existence of the corporation is perpetual.

Article IV PURPOSES



 - B. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations.
 - C. notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by:
 - 1. A not for profit corporation under Chapter 611, Florida Statute.§, or any other corresponding provision of any future Florida Statute; or
 - 2. Any corporation, contributions to which are deductible under Section 170(cX2) of the Internal Revenue Code of 1954 or corresponding section of any future federal tax code; or,
 - 3. A corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code of 1954 or corresponding section of any future federal tax code.
