### **Articles of Incorporation**

FILED

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statues, -3 P 4: 59 adopts the following Articles of Incorporation for such a corporation:

### Article I:

The name of the corporation shall be: Foot Print to Success Clubhouse, Incorporated.

### Article II:

The principal place of business of this corporation shall be:

### Article III:

The purposes for which the corporation is organized are exclusively for, and will be operated exclusively for, one or more of the purposes (religious, charitable, etc) within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. The corporation will carry out this purpose by providing rehabilitative services to people with mental illness through gifts, donations, bequests and grants; while providing meaningful work opportunities for people with mental illness and promoting mental illness recovery. The period of duration of this corporation is perpetual unless dissolved according to law. Subject to the limitations applicable to Section 501 (c) (3) organizations, the corporation shall have the general powers set forth in Section 617.0302, Florida Statue.

### Article IV:

The method of election is as stated in the bylaws. The bylaws read as follows: The members of the first Board of Directors shall be appointed by the incorporator, 1/3 of the directors shall each serve for a term of one year or until a successor is elected and qualified, 1/3 of the directors shall each serve for a

term of two years or until a successor is elected and qualified, and 1/3 of the directors shall each serve a term of three years or until a successor is elected and qualified. Thereafter, expired terms will be filled by those persons elected by the Active Members of the Clubhouse at the Annual Membership meeting from a slate of persons nominated by the Board or Directors.

This corporation is a nonmember ship organization.

### Article V:

The number constituting the initial Board of Directors of this corporation is three, and the names and addresses of the persons who are to serve initially are:
