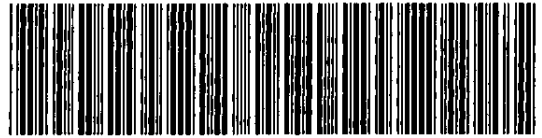

ARTICLES OF INCORPORATION

ARTICLE I

The OFFICIAL NAME of this corporation is: GOD'S WORK OF LOVE MINISTRIES, INC.

ARTICLE II

The PURPOSE or purposes for which the corporation is formed are:

- a. To forward the Kingdom of God the Father, the Son and the Holy Spirit
- b. To do all the acts and things necessary to includes, but not limited to Christian counseling, guidance and instruction.
- c. Conducting schools, services, and all other types of meetings or activities which may be necessary or required to cause people to be born again, and to become workers in and for the Kingdom of God.
- d. To build and maintain churches, orphanages, schools, and other facilities, building or structures to forward the work of the Kingdom of God.

11. Benediction.


ARTICLE X

FISCAL YEAR. The fiscal year of this corporation shall be fixed by the proper resolution of the Board of Directors.


