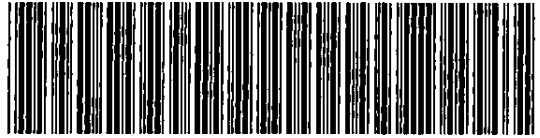

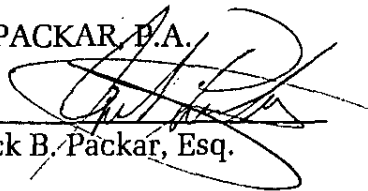

**ARTICLES OF INCORPORATION
OF
FEED THE WORLD FOUNDATION, INC.**

By these Articles of Incorporation the incorporators hereby form a Corporation not-for-profit under the laws of the State of Florida, pursuant to Florida Statutes 617.

**ARTICLE I
NAME**

The name of the Corporation is: Feed The World Foundation, Inc.

**ARTICLE II
ADDRESS**

The street address of the principal office of the Corporation is:

Miramar, Florida 33023.

**ARTICLE III
PURPOSE**

The general nature of the this non-profit corporation and the objects and purposes proposed to be transacted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do:

A. To establish a foundation to help people in need. To provide charitable services to individuals and families; also to provide information, tools, food, shelter, medical assistance, financial assistance and business opportunity to improve their quality of life.

B. The focus is to make a difference in the world.

C. To receive by means of gifts, donations, devises and bequests, real and personal property, and to hold, care for, invest and reinvest in the same, and to use the proceeds thereof for the purposes set forth herein.

D. To facilitate and execute the business and activities of Feed The World Foundation, Inc. and to conduct any and all business of the corporation including acquiring and disposing of real and personal property in compliance with the requirements of the State of Florida..

**ARTICLE IV
STOCK**

This Corporation shall issue no shares of stock of any kind or nature whatsoever. There shall be no dividends paid to any of the members.

ARTICLE V
REGISTERED AGENT

The initial street address of the Corporation's registered office is: 6142 Miramar Parkway, Suite E, Miramar, Florida 33023. The initial registered agent for the Corporation at that address is: Jacques Armand

ARTICLE VI
CORPORATION NOT-FOR-PROFIT

No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law, or by corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Code. On the dissolution of this corporation the board of Directors shall dispose of all the assets of this corporation exclusively for the purposes of this corporation to an organization organized and operated exclusively for charitable purposes and that qualifies as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not disposed of shall be distributed to the Federal government, or to a State or local government, for a public purpose, and none of the assets will be distributed to any member, Officer or Director of this corporation.

ARTICLE XII
MEMBERSHIP

Any person who subscribes to and accepts the purposes of this corporation as set forth herein above, may be a member of this corporation.

ARTICLE VIII
BOARD OF DIRECTORS

The initial board of directors shall consist of three members. This number may be increased from time to time in accordance with the Corporations's bylaws, but shall never be less than three. The names and addresses of the persons who will serve on the initial board of directors are:
