ARTICLES OF INCORPORATION in Compliance with Chapter 617, F. S., (Not for Profit)

- 1) The undersigned, a majority of whom are citizens of the United States, come together this 6th day of May, 2010 to incorporate a non profit church in the State of Florida, United States of America, subject to the laws and regulations therein. The name of the corporation shall be Sacred Earth Center Inc.
- 2) The principal office of the Sacred Earth Center will be 3131 NW 13th Street, #41, Gainesville, Florida, 32605 in Alachua County. The mailing address will be 9564 254th Terrace, O'Brien, Florida, 32071.
- 3) The Sacred Earth Center exists exclusively for religious purposes, as a church, to provide healing for the whole being, training of spiritual healers and ministers, counseling, teaching, ceremony, prayer. The Chapel is interfaith, honoring and providing exploration and encouragement for the individual spiritual path. The Chapel seeks to promote union between Creator, Humanity, and Earth.
- 4) The Church honors the traditional form of the nonhierarchical circle in its governance and function.
- 5) The Governing Board (Board of Directors) of the Sacred Earth Center, hereafter referred to as the Council, shall consist of a circle of six Council Members of equal authority, coordinated by one Council Member, hereafter referred to as Facilitator. Decisions shall be made by consensus, in the tradition of a sacred circle, as such: Council members shall speak in turn. After each member has had a turn to speak or to pass on the opportunity to speak, the cycle will start over until each has had a turn speaking again. The cycle will continue until consensus is reached. If no consensus is not reached in due time, the decision on the issue at hand shall be "no."
- 6) Any Council Member may nominate any individual to become a Council Member. The decision whether to adopt that individual as a member of the Council will be reached by the Council by consensus. If no consensus is reached within one meeting of the Council, the decision will be "no" not to adopt that individual to the Council.
- 7) Upon dissolution of the Sacred Earth Center, any financial assets will be donated to a non profit, tax exempt incorporated organization.
