The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Law Statute 617, adopts the following Articles of incorporation.

**ARTICLE I  
NAME**

The name of the corporation shall be:

**PLUS SIZE WOMEN COMMUNITY DEVELOPMENT CORP.**

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE III  
PURPOSES**

1. To serve as a mentorship program for female youth and juveniles.
2. To repair the disparities in academic achievement between African American females and other ethnic groups.
3. To mentor African-American females in the development of long and short term life goals objectives.
4. To develop and implement a program to elevate the self-esteem of African-American female youth and young adults.

5. To operate exclusively for charitable, religious, and educational purposes within the meaning of section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 ( c ) ( 3 ) corporation. "However" if the named recipient is not in existence as a distributee, or unwilling to accept the distribution, the assets shall be distributed to a fund, or foundation, or organization which is operates exclusively for purposes specified in section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

#### ARTICLE V LIMITATION OF POWERS

Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization Exempt from federal income tax under section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.




ARTICLE VII




