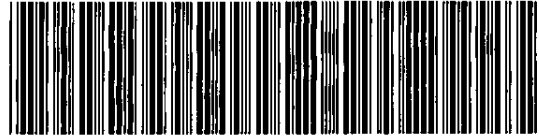

ARTICLES OF INCORPORATION
In Compliance with Chapter 617,FS., (Not for Profit)

ARTICLE I NAME

The name of this Corporation shall be: City of Miami Black Police Precinct and Courthouse Museum, Inc.

ARTICLE II PRICIPAL OFFICE

The corporation principle place of business and mailing address shall be 480 NW 11th Street Miami Florida 33136.

ARTICLE III PURPOSE

To continue the preservation of the history of the City of Miami, Negro Police Precinct Courthouse, In addition the corporation is organized exclusively for charitable, religious, educational, and scientific, purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (C) (3) of the Internal revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from the federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
