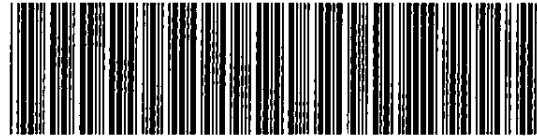

ARTICLES OF INCORPORATION
OF
KING HIGH SCHOOL CLASS OF 1965, INC.

ARTICLE I

This corporation shall be known as and named King High School Class of 1965, Inc., and it shall be a corporation, not for profit, in accordance with Chapter 617 of the Florida Statutes.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:
6615 Glencoe Drive, Temple Terrace, Florida 33617.

ARTICLE III

The purpose for which the corporation is organized is to conduct a class reunion of the 1965 graduating class of C. Leon King High School of Tampa, Hillsborough County, Florida and to conduct all business associated with that purpose and any other lawful purpose authorized under Chapter 617 of the Florida Statutes.

ARTICLE IV

The manner in which the Directors are elected or appointed shall be by a vote of the membership at the first meeting of the general membership of the corporation in a manner specified by the By-Laws, and they shall serve and hold office until the next annual meeting of the general membership. The purpose and general affairs of the corporation shall be managed by its Board of Directors.

ARTICLE V

The day to day affairs of the corporation shall be managed by a president, secretary and treasurer. These officers shall be elected at the first meeting of the general membership of the corporation in a manner specified by the By-Laws. The following persons shall serve as the corporation's initial officer positions until an election is held at the first meeting of the general membership. Their names, addresses and respective titles are as follows:

ARTICLE VI

The Board of Directors shall consist of not less than three (3) persons and as many as shall be determined to be needed by the Board of Directors from time to time. The initial Board of Directors, including their names and addresses, will be:

2. Max Ramos, 20320 Mid Court, Lutz, Florida 33558
3. Michele Gates, 5109 Whispering Leaf Trail, Valrico, Florida 33594

The above-named directors shall serve until the first election of the first meeting of the general membership as set out in Article IV, herein; whereupon, directors shall be elected in a like manner and serve for a like term as set out in Article IV, herein.

ARTICLE VII

ARTICLE X

The existence of the King High School Class of 1965, Inc., shall be until March 31, 2011.

ARTICLE XI

The By-Laws of the corporation shall be made, altered or rescinded by a majority vote of the members, who may cast their vote through their designated representative.

ARTICLE XII

Amendments to the articles of incorporation shall be accomplished in a like manner as set out in Article XI, herein; provided any proposed amendment is submitted to the

president in writing and sponsored by at least three (3) members who shall affix their signatures thereto. Such proposed amendment shall be presented at no less than two (2) successive meetings of the general membership prior to a vote on it.

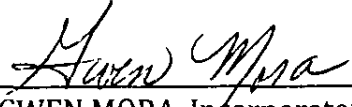
ARTICLE XIII

ARTICLE XIV

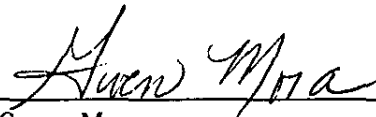
The corporation shall have all the powers authorized by Chapter 617 of the Florida Statutes.
