The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation.

ARTICLE I: Name

ARTICLE III: Purpose

This corporation is organized exclusively as a trade association that meets the requirements of Internal Revenue Code Section 501(C)(6) of the Internal Revenue Code and is exempt from federal income tax as a business league. Its purpose is to promote the aviation interests of individuals and corporations, primarily in the Tampa Bay Region of West Central Florida, operating aircraft as an aid to the conduct of their businesses; to foster among them the highest degree of operational efficiency and safety; to bring Members into closer personal and friendly relations with each other; to interchange ideas on operational matters; to advance and maintain an enlightened understanding on the part of government and airport authorities of Member problems; to take such steps as are proper and necessary in order to promote better relations and secure proper advantages from regulatory and other agencies, and by these means to attain wider recognition of the fact that business aviation is of primary importance to the economy of Pinellas County, the State of Florida and the nation.

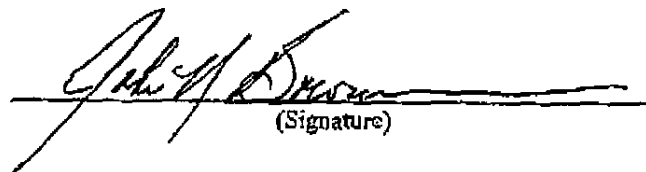

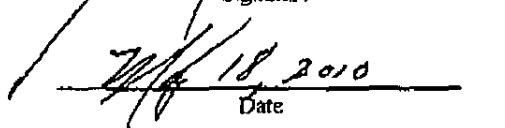
