ARTICLES OF INCORPORATION

OF

FLORIDA PANHANDLE PATRIOTS, INC., Non-Profit Organization



I, the undersigned natural person, being of the age of eighteen (18) years or more, acting as incorporator hereby adopt the following Articles of Incorporation for such corporation.

Article I

The name of the Corporation is Florida Panhandle Patriots, Inc.

Article II

The corporation is a non-profit corporation.

Article III

The principal place of business and mailing address of the corporation is 264 Chipola Cove, Destin, Florida 32541, Okaloosa County

Article IV

The period of duration of the Corporation is perpetual.

Article V

The purpose for which the Corporation is organized is:
