Upon the dissolution and winding up of the organization (Corporation), after paying or providing for the debts and obligations of the organization, the remaining assets shall be distributed to a church or another nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in section 501(C)(3) of the Internal Revenue Code of 1986 and which has established its tax-exempt status under that section or corresponding section of any future federal tax code; or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine.
