ARTICLES OF INCORPORATION

Article I

Name

The name of this Corporation shall be: **" RESCUE HAITIAN CHILDREN AT RISK INC."**
(RHACHAR)

Article II

Purposes

This corporation is a not-for-profit Corporation, organized for educational and charitable purposes, including not limited to the following:

- 1) To assist in the maintenance and or development of a more equitable education for the underprivileged immigrant and local children.
- 2) To receive, administer, invest and apply gifts, donation, bequests and contributions in various forms and in the interest there from, for the purposes described herein; and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which a not for profit corporation may be organized, so far as it may be permitted by the laws of the State of Florida and Section 501 (c) (3) of the Internal Revenue Service code as amended.
- 3) To promote education and give the opportunity and assist of an equitable education to the needy students of Haiti whom can not afford to go to school who are at risk and give them the opportunity to fit in the society and prevent delinquency.

Article III

Membership

Any person, corporation, partnership, association or organization who is interested in the purposes of the corporation who is capable of contributing to the achievement of those purposes and the effective operation of the corporation, and who complies with the requirements established here by the Bylaws shall be eligible for membership.

Article IV
Initial Registered Office and Agent

The Street and address of the initial office of the Corporation is 10509 SW 17th Court Miramar Florida 33025 and the name of the corporation's initial registered Agent at that address is Eddy Aurélien. And also the principal place of the business.

Article V
Board of Directors

The affairs of this Corporation shall be managed by a board of directors consisting of no less than (3) directors, The directors of the corporation shall be those persons who shall have been appointed to that office by the presiding director.

The number of directors may be increased or decreased from time to time in accordance with the bylaws of the corporation, but shall never be less than three. The name and address of the persons who shall serve as the initial directors of the corporation are as follow:

Article VI

Article VII
Dissolution

Upon any dissolution of this Corporation, its assets remaining after payment or provision for payment of all debts and liabilities of the corporation shall be distributed to a not-for-profit fund, foundation or corporation designated and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Service code of 1954 as amended or corresponding provisions of any subsequent federal tax laws.

Article VIII
Limitations

No part of the net earnings of the Corporation, shall insure to the benefit of or the distribution to its directors, officers, members or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on propaganda or otherwise attempting to influence legislation (except as otherwise provided in subsection (h) of section 501 of the Internal Revenue Service code of 1954, and the Corporation shall not participate or intervene in (Including the publishing or distributing of statements) any political campaign on behalf of any candidate or any candidate for public office. Notwithstanding any provision of the articles by the corporation shall not carry on any activities not permitted to be carried on (a) by Corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future U.S. Internal revenue law or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or corresponding provision of any future U.S. Internal Revenue Service laws.



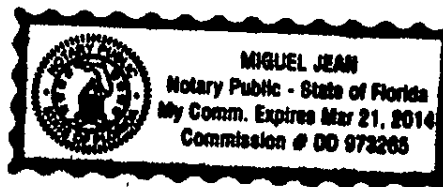
