In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

RAP International Christian Ministries, Incorporated

ARTICLE II PRINCIPLE OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. RAP International Christian Ministries, Incorporated is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purpose, the making of distribution to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code,
- B. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution or statements) any political campaign on behalf of any candidate or public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to the carried on (a) by and organization exempt from federal income tax under section 501 (c)(3), of the Internal Revenue Code. Or corresponding section of any future federal tax code, or (b) by any organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

- C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The Board of Directors shall be appointed by the Office of the Pastor of RAP International Christian Ministries, Incorporated. Each Board Member shall serve a term of one year calendar month and shall be appointed in the anniversary month of the inception of the organization.
