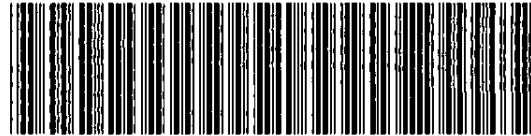



## **ARTICLES OF INCORPORATION**

of

### **Society Overcoming Seizures, Inc.**

Pursuant to the provisions of Chapter 617 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Incorporation of Society Overcoming Seizures Foundation, Inc., originally incorporated on April 23, 2010.

#### **ARTICLE I: NAME**

The name of the corporation is: Society Overcoming Seizures, Inc.

#### **ARTICLE II: PRINCIPAL OFFICE**

The principal street and mailing address of the principal office is: 1707 S.E. 11<sup>th</sup> Street, Ocala, Florida 34471.

#### **ARTICLE III: PURPOSE**

This corporation is a not for profit corporation. This corporation is organized exclusively for educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law. Specifically, this corporation is organized to fund, promote, and conduct research concerning epileptogenesis and epilepsy performed by Dr. Paul R. Carney and his team at the University of Florida's McKnight Brain Institute Epilepsy Research Laboratory. This corporation will provide funds to further allow Dr. Carney, by and through the students and faculty affiliated with Dr. Carney's laboratory, to achieve our shared goal of understanding the mechanisms of epilepsy and to apply this knowledge to the development of new treatments and cures.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future United States internal revenue law, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future United States internal revenue law.

#### **ARTICLE IV: MANNER OF ELECTION**
