

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For  
Profit Corporation adopts  
the following amendment(s) to its Articles of Incorporation:

**ARTICLE I NAME**

The name of the corporation shall be:

**The Center for Victim Recovery, Inc.**

**ARTICLE III PURPOSE**

- a) The purpose for which the corporation is organized is to offer no-cost counseling, support, and education to victims of crime and violence.
- b) The organization will offer community education and activities.
- c) The Center for Victim Recovery is organized exclusively for charitable purposes under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence Federal legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

*e) Dissolution of Assets Provision:*

Upon the dissolution of the organization the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**ARTICLE IV MANNER OF ELECTION**

Directors will be elected according to their ties to the community and level of commitment to fulfilling the Purpose (Mission) of the organization.
