Article VIII

The corporation shall have power to:

- a. Own and convey property;
- b. Operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas.
- c. Establish rules and regulations;
- d. Assess members and enforce assessments;
- e. Sue and be sued;
- f. Contract for services to provide for operation and maintenance of the surface water management system facilities if the association contemplates employing a maintenance company;
- g. Require all the lot owners, parcel owners, or unit owners of the subdivision known as Hilltop Acres in Hardee County, Florida, to be members;
- h. Exist in perpetuity; however, if the corporation is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public unit and that if not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the corporation;
- i. Take any other action necessary for the purposes for which the association is organized.
