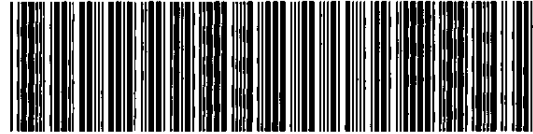

Articles 1: Prayer of Salvation Learning Center, Inc.

Article 11: The principle place of business and mailing of this corporation shall be: **634 Pineville Lane, Lakeland, Florida 33810**

Article 111: The specific purposes for which this corporation is organized: Will be to provide children the age's one through five of all backgrounds with the opportunity to advance in an educational setting. We will provide each child with a variety of learning experiences, including those of the arts (some which include music, dance, drama, and foreign languages).
