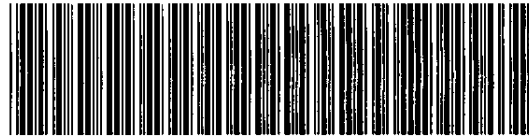

# **ARTICLES OF INCORPORATION**

**OF**

## **HOPE ON THE MOVE, INC.**

### **PREAMBLE**

**For the preservation and security of the principles of our faith, and being good Samaritans; and to the end that this faith-based non-profit business and ministry may be governed in an orderly manner consistent with the accepted tenants of God's Word; and to reach out to the lost and hurting people of the world, we declare and establish these Articles of Incorporation.**

### **I - NAME AND REGISTERED ADDRESS**

The name of this corporation shall be HOPE ON THE MOVE, INC. and said corporation shall be located in Gainesville, Alachua County, Florida, at its registered address at 7456 SW 116th Terrace, Gainesville, FL 32608, or at such other place as the Directors may from time to time designate.

### **II - NATURE, PURPOSE AND OBJECTS**

This corporation will be a corporation not-for-profit, and the general nature, purpose and objects of this corporation shall be exclusively for providing health, heart and soul ministry including medical, dental, Christian and spiritual services, assistance and ministering to victims of natural or manmade disasters, including the constructions of buildings and facilities as set forth below:

A. To do any and all things usual and necessary to further the aims and objects of the Lord Jesus Christ, to lift up the fallen, provide shelter for the homeless, care for the sick, feed the hungry, clothe the naked all as part of the sharing the Good News of Jesus Christ and his ministry in all the world by the command of our Lord Jesus Christ.

B. To attempt to, but not limited to, maintain a program of activity and affiliation with any other similar outreaches and ministries, churches, hospitals, clinics, and/or associations of like interests, faith and belief.

C. To organize facilities for medical, dental, etc. to provide for the physical, mental, psychological, emotional, mental and spiritual needs of such victims of major disasters and through hospitals, clinics, ministries and churches

which may organize or set up other churches, to provide an outreach in the local area of any such and to the uttermost parts of the world as the Holy Spirit leads.

D. To receive donations, grants, gifts, etc., as a tax exempt entity under the various sections of the Internal Revenue Code for donors of every level.

E. To engage in and perform all phases of construction for houses, hospitals, clinics, orphanages, apartments and any type of housing facilities and any necessary support facilities and to associate with groups in the construction and building industries for same and to hire personnel in conjunction therewith for the homeless, etc.

F. To serve as a legal entity to handle the business affairs of **HOPE ON THE MOVE, INC.** with power to perform all acts not inconsistent with the aims and object of said business and ministry and to buy, lease and hold the title of land necessary for the purposes herein.

G. To perform all functions and to have all powers as permitted by Chapter 617, Florida Statutes 2009, and such powers as corporations not-for-profit may otherwise now or hereafter have or acquire; provided, however, that this corporation, in exercising any one or more of such powers shall limit itself to those powers as provided or described in Sections 501 (c) (3) or 507 or 508 of the Internal Revenue Code.

### **III - MEMBERSHIP**

There will be no governing members of this family ministry except for the members of the Board of Directors and officers, except as provided in the bylaws.

### **IV - TERM OF EXISTENCE**

The term for which this corporation shall exist shall be perpetual unless otherwise directed by the Board of Directors. The term began on the date this corporation is approved by the Secretary of State, Tallahassee, Florida.

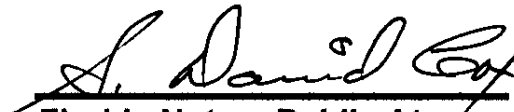
