ARTICLES OF INCORPORATION  
FOR



The undersigned incorporator of these Articles of Incorporation, desiring to form a perpetually existing corporation not for profit pursuant to chapter 617, Florida Statutes, as amended.

**ARTICLE 1 - NAME OF THE CORPORATION**

The name of the corporation shall be known as New Life Outreach Mission, Inc.

**ARTICLE 2 - DURATION**

The period of its duration is perpetual, unless dissolved according to law, no stock and shall have no members.

**ARTICLE 3 - PURPOSE (S)**

**ARTICLE 4 - PRINCIPAL PLACE OF BUSINESS**

**SECTION 1. PRINCIPAL OFFICE**

The principal office of New Life Outreach Mission, Inc. for the transaction of its business is fixed and located at 1560 N.W. 69<sup>th</sup> Street, Miami, Florida 33147

**SECTION 2. CHANGE OF ADDRESS**

The address of New Life Outreach Mission, Inc. principal office can be changed only by amendment of these Bylaws and not otherwise. The Board of Directors may, however, change the principal office from one location to another within the named county by noting the change address and effective date below, and such changes of address shall not be deemed an amendment of these Bylaws.

**SECTION 3. OTHER OFFICES**

New Life Outreach Mission, Inc. may also have offices at such other places, within or without the State of Florida, where it is qualified to do business, as its business may requires and as the Board of Directors may, from time to time, designate.

**ARTICLE 6 – OFFICERS**

The officers of New Life Outreach Mission, Inc. shall be: President; Vice President; Secretary; and Treasurer.

**ARTICLE 7 – BOARD OF DIRECTORS**

The Directors are elected in accordance with the bylaws. A director must be 18 years of age. The number of directors shall be three (3). The names and address of the persons appointed to act as the initial directors of New Life Outreach Mission, Inc. are:

**ARTICLE 8 – PURPOSE(S)**

The specific purpose for which the corporation is organized is exclusively for charitable, religious, educational, purpose within the means of Section 501(C) (3) of the Internal Revenue Code.

New Life Outreach Mission, Inc. is organized under the Non-Profit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a **LIFE** of self-sufficiency. In accordance with the doctrine of New Life Outreach Mission creed/by-laws as an Elder to spread the Gospel of Jesus Christ. The outreach missions will consist of but shall not be limited to: Job Training; Job Placement; Land Acquisition; Housing; Employment; Literacy; Counseling; Temporary Shelter; Teenage Pregnancy; Substance Abuse Awareness and Prevention; Tutoring; Aids; Elderly Care and other outreach missions to aid those in need.

New Life Outreach Mission, Inc. is not for a private gain. No part of the net earnings of New Life Outreach Mission, Inc. shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that New Life Outreach Mission, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered. To make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of New Life Outreach Mission shall be the carry on of propaganda. Otherwise attempting to influence legislation and New Life Outreach Mission shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any part of these articles. New Life Outreach Mission shall not carry on any other activities not permitted to carry on: (A) By a corporation exempt from federal income tax under Section 501(C) (3) of the Internal Revenue Code, or the corresponding section of any future federal income tax code. (B) By a corporation, contributions to which are deductible under Section 170(C) (2) of the Internal Revenue Code, or the corresponding section of any future tax code.

**ARTICLE 9 - CORPORATION DISSOLUTION**

The Corporation Dissolution of Assets, upon the dissolution or winding up of New Life Outreach Mission, Inc., its assets remaining after payment or provision for payment of all debts and liabilities of New Life Outreach Mission, Inc., shall be disposed of by the Board of Directors of New Anointing Prayer International Ministries, Inc. located at 9050 NW 20<sup>th</sup> Avenue, Miami, Florida 33147, in which New Life Outreach Mission is an outreach mission of New Anointing Prayer International Ministries, Inc, an exclusively religious and charitable purpose organization, as said Ministry shall determine, which has established its tax exemption status under Section 501(C)(2) and 170(C)(2) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

**ARTICLE 10 - REGISTERED OFFICE AND REGISTERED AGENT**

The initial address of registered office of New Life Outreach Mission, Inc. is 1560 N.W. 69<sup>th</sup> Street, Miami, Florida 33147. The name and address of the registered agent of New Life Outreach Mission, Inc. is Elder Robert L. McDuffie, Jr. located at 1560 N.W. 69<sup>th</sup> Street, Miami, Florida 33147.

**ARTICLE 11 - EFFECTIVE DATE**

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

**ARTICLE 12 - AMENDMENT**

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors by a majority of the Board, unless all the Directors sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
