ARTICLE III

The specific purposes for this corporation is organized are:

2. To license ordain ministers to perform the duties, services, and functions of a licensed and ordained minister.
3. To serve as community reach-out ministries to the sick, shut-in, prison population, convalescent homes, hospitals and homeless.
4. To serve as an education center to the extent of empowering members and to fully engage Christian life through lectures, symposiums, seminars, biblical scholarship, and radio and television broadcast.
5. To serve as a media center to promulgate and proliferate the good news of the gospel of JESUS CHRIST and the Kingdom of God via print, online publications, tapes, videos and web presence.

The purposes for which I LOVE JESUS WORSHIP CENTER, INC. is organized as exclusively religious, charitable, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding, any other provisions of these articles, I LOVE JESUS WORSHIP CENTER, INC., shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

All titles, copyrights, royalties or similar interest in electronic recordings, books, online publications or any other materials prepared for I LOVE JESUS WORSHIP CENTER, INC. activities will be held by I LOVE JESUS WORSHIP CENTER, INC. activities will be held by I LOVE JESUS WORSHIP CENTER, INC. and its name.

Articles of Incorporation Dissolution of assets provision

The distribution of assets upon dissolution or final liquidation shall be as follows:

I LOVE JESUS WORSHIP CENTER, INC. shall be perpetual, upon dissolution of I LOVE JESUS WORSHIP CENTER, INC. assets shall be distributed to one or more designated exempt, not for profit organization(s) within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
