## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CIVIL RIGHTS MUSEUM OF ST. AUGUSTINE, INC. In Compliance with Chapter 617, F.S., (Not for Profit)

DOCUMENT NUMBER: N10000005488

PURSUANT TO the provisions of Chapter 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the following amendments to its Articles of Incorporation:

### ARTICLE III: PURPOSE

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## ARTICLE IX: CORPORATE ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The amendments were adopted by the Board of Directors and a vote was not required by the members.

The effective date of the adoption of the above-stated amendments is April 21, 2011.
