ARTICLE III: The specific purpose for which this corporation is organized is:

- a) To promote and enhance the culture of Trinidad and Tobago by engaging in programs and activities such as promoting Carnival replica and Steel band orchestra.
- b) To promote wellness throughout the communities in Central Florida, by conducting health fairs on an annual basis.
- c) To assist high school students in Central Florida through our scholarship award program. There will be three (3) scholarships given out at the scholarship award event.
- d) To foster a relationship to the under privileged by adopting homes such as the battered women shelter.
- e) Annually we will donate to the following organizations such as:- Kidney Foundation. American Red Cross, Churches, Cultural Youth Groups, both in Central Florida and in Trinidad and Tobago.
- f) Said Organization is organized exclusively, for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempted organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- g) No part of the net earnings of the organization shall inure to the benefit of , or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other purposes not permitted to be carried on
 - (a) By an organization exempted from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code
 - or
 - (b) By an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future tax code.
- h) Upon the dissolution of the organization, assets shall be distributed for one or more exempted purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which or organized and operated exclusively for such purposes.
