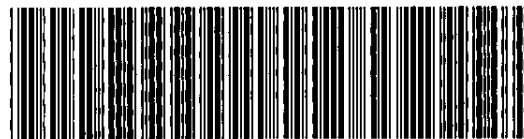

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a not for profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE I – NAME

The name of the corporation shall be Passion for Haiti Foundation, Inc.

ARTICLE II – PRINCIPLE OFFICE

ARTICLE III– PURPOSE

The organizational purpose of Passion for Haiti Foundation, Inc. is to help the less fortunate people in the country of Haiti. Our organization will send volunteers and support to assist the poor, homeless, elderly, orphans, and widows. In addition, we will assist in emergency relief efforts.

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
