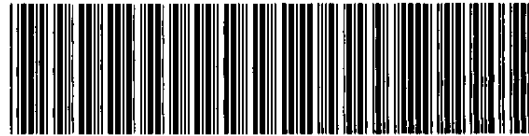

1. How do I add the tax id to reflect on this "Detail by Entity Name" page? or is it necessary to have included?

2. The language in Article III of our Document Image (6/10/2010) is incorrect due to several changes and rejections sent back and forth at the time of submission and the corrected language did not get put in place during those changes. It should have read "nonprofit charitable organization,..., which has been held to be tax-exempt organizations under Section 501 of the Int Rev Code...Football Team"

I was told the language was too long so we had to cut it down to fit.
