ARTICLE III PURPOSE

This Article shall now read:

The purpose of the corporation shall be to provide financial support to the band program, to support the goals and objectives of the band program, to foster parental involvement, support and communication between the band director, band parents and the band members, and for educational purposes.

Said organization is organized exclusively for charitable and education purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XII NON-PROFIT STATUS

This Article shall now read:

No part of the net earnings of this corporation shall inure to the benefit of any individual or member. No substantial part of the activities of this corporation shall be for carrying on propaganda or otherwise attempting to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office. Upon dissolution of this corporation, all assets of the corporation remaining after payment of all costs and expenses of such dissolution shall be turned over to Flagler Palm Coast High School and placed in the Band General Fund.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
