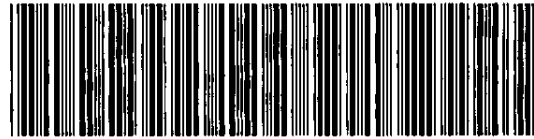

**FIRST:** The name of this Corporation as currently filed with the Florida Department of State is: North Sumter County Utility District, Inc., Document No. N10000005645.

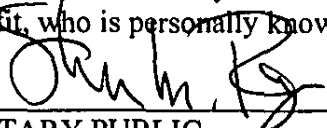

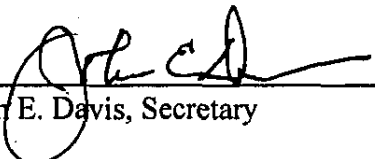

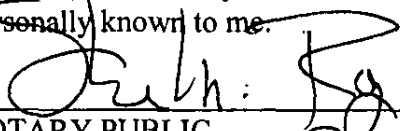

**PLAN OF DISTRIBUTION OF ASSETS  
OF  
NORTH SUMTER COUNTY UTILITY DISTRICT, INC.  
(A Florida corporation not for profit)**

The Directors fully acknowledge and agree that, upon the action of the Sumter County Board of County Commissioners, taken on July 13, 2010, adopting the Ordinance creating the North Sumter County Utility Dependent District, the Corporation has fulfilled and satisfied its sole purpose as set forth in Article 3 of the Corporation's Articles of Incorporation.

Therefore, the Directors resolve that the Corporation shall be dissolved, effective immediately, and that Mr. John E. Davis, as Secretary of the Corporation, is hereby authorized and directed to take all actions necessary to dissolve the Corporation, including but not limited to delivering to the Florida Department of State Articles of Dissolution for filing.

Further, the Directors hereby adopt the following Plan of Distribution of Assets:

1. The Corporation shall pay to McLin Burnsed the fee of \$78.75 for costs incurred in creating the Corporation, and \$43.75 for costs incurred in dissolving the Corporation;
2. Subsequent to making the payment referenced in the paragraph 1 above, there are no remaining liabilities and obligations of the Corporation; and
3. All remaining assets of the Corporation, which consists of the sum of \$9,877.50, shall be distributed to the North Sumter County Utility Dependent District in accordance with those conditions set forth in the monetary contribution to the Corporation and Article 16 of the Corporation's Bylaws.

The Directors further hereby resolve that a copy of the Plan of Distribution of Assets shall be filed with the Florida Department of State, containing the Officer's Certificate of Compliance in accordance with Section 617.1406(4), Florida Statutes, and that Mr. John E. Davis, Corporation Secretary, be authorized and directed to make such filing.
