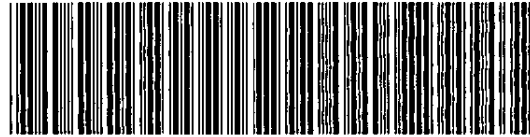

The undersigned incorporator, for the purpose of forming a Not for Profit Corporation hereby adopts the following Articles of Incorporation:

Article I: NAME

The name of this organization is Clinton Harris Ministries, Inc.

Article II: ADDRESS

Clinton Harris Ministries, Inc. is located at street address: 3660 Welsch Way, Lakeland, FL 33813.. The mailing address is PO Box 1595, Highland City, Florida 33846-1595.

Article III: PURPOSE

Clinton Harris Ministries, Inc. has the vision and purpose of being a global evangelistic ministry dedicated to fulfilling the Great Commission of our Lord Jesus Christ to "Go ye into all the world and preach the Gospel..."
We intend to do this in three primary ways:

- 1) Preaching the gospel in person through revivals and crusades domestically and abroad in churches and other venues, conducting missions to our homeland and abroad to further the gospel of Jesus Christ by the spoken word.

Treasurer & Chief Financial Officer: Amy Harris




