Attachment to Articles of Incorporation of

Walk the Walk World Wide, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is: Provide reconstructive surgery to patients suffering from lower extremity deformities or injuries and to provide medical education and training to physicians and other healthcare providers in areas of great need through the charitable contributions of time, money, expertise, and medical and surgical supplies.
