**Articles of Incorporations  
Of

Articles of Incorporations of the undersigned, of which all are citizens of the United States, desiring to form a Nonprofit Corporation under the Laws of Florida, do hereby certify:

**Article 1:** The name shall be called

**Charles H. Pearce Center for Public Policy Inc.**

**Article 2:** The place in Florida where the principle office of **Charles H. Pearce Center for Public Policy Inc.** is to be initially located in the city of Tallahassee, Florida at 471 E. Van Buren Street 32301

**Article 3:** **Charles H. Pearce Center for Public Policy Inc.** is organized exclusively for charitable, educational, health and other activities based on educating the public on policies that affect the public. Including such purpose as making of distribution to organizations that qualify as exempt organizations and/or are classified as 501(c) (3) of the Internal Revenue Code, or corresponding section of any future tax code. The specific purpose of **Charles H. Pearce Center for Public Policy Inc.** shall be to host Public Policy forums across the state of Florida on issues that affect our Country.

**Article 4:** The directors of **Charles H Pearce Center for Public Policy Inc.** shall be appointed annually by the President who shall be elected by the directors.

**Article 5:** No part of the earnings of **Charles H. Pearce Center for Public Policy Inc.** shall insure to the benefit of or be distributed to its members or other private persons, except that **Charles H. Pearce Center for Public Policy Inc.** shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment for lease or rental equipment and distribution in furtherance of the purpose set forth in Article 3 hereof. No substantial part of the activities of **Charles H. Pearce Center for Public Policy Inc.** shall be the carrying on of propaganda, or otherwise

attempting to influence legislation, shall not intervene, publish, and distribute any statements, in any political campaign on behalf of or in opposition to any candidate for public office. **Charles H. Pearce Center for Public Policy Inc.** shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of **Charles H. Pearce Center for Public Policy Inc.**

**Article 6:** Upon the dissolution of **Charles H. Pearce Center for Public Policy Inc.** assets shall be distributed for one or more exempt purpose within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the State of Florida or local government for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Court of Competent Jurisdiction of Leon County in which the principal office **Charles H. Pearce Center for Public Policy Inc.** is located, exclusively for such purpose or to such organizations, as said Court shall determine which are operated exclusively for such purpose.

**Article 7:** The registered agent and office of **Charles H. Pearce Center for Public Policy Inc.** shall be Kyle C, Gibson. 471 E Van Buren Street Tallahassee, Fl 32301.

**Article 8:** **Charles H. Pearce Center for Public Policy Inc.** shall have membership. The qualifications and rights shall be spelled out in the Bylaws.

**Article 9.** The period of time for **Charles H. Pearce Center for Public Policy Inc.** is perpetual.

**Article 10.** Names and addresses of Initial Incorporator shall be Kyle C. Gibson 471 E Van Buren Street Tallahassee, Florida 32301
