Amendment 1.

Said organization is organized exclusively for charitable, religious, educational, and scientific purpose, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 50(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
