ARTICLES OF INCORPORATION OF
CULTIVAMOS UNA ROSA BLANCA, INC.

WE, the undersigned, do hereby form a Not for Profit Corporation under the Chapter 617 of the Florida Statutes and do hereby adopt the following Articles of Incorporation.

ARTICLE I.

The name of this corporation shall be: CULTIVAMOS UNA ROSA BLANCA, INC.

ARTICLE II.

The principal place of business and the mailing address of this corporation shall be:
1820 East Hallandale Beach Boulevard, Hallandale Beach, FL 33009

ARTICLE III.

(a) The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the internal Revenue Code, or the corresponding section of any future federal tax code.

(b) Said corporation is further organized to seek to promote help through peaceful means for individuals who have engaged in rebellion and protests to express their determination for fair justice and freedom for dissents in countries where tyranny and oppression are a way of life. The corporation aims to facilitate and encourage opportunity for individual freedom and social progress leading to improve living standards of life and self determination by building awareness and pressure for action against human rights abuse and to increase consciousness of such abuse to protect people at risk.

(c) To promote respect for human rights and rule of law to which ever citizen is entitled and to obtain international recognition for people who are protesting against human rights violating even at expense of their own safety and life.

(d) The corporation plans to advocate on behalf of individuals whose human rights are violated reaffirming the fundamental rights of people who must recourse to rebellion against tyranny and oppression to defend their rights to self determination and to advocate for peaceful solutions to such conflicts.

(e) The corporation will utilize means of communication such as Internet, radio, T.V., newspapers, press releases, blogs, etc. as well as national and international forums and invitations to well known and respected individuals of the community to lend their support to the corporation's human rights cause to protect people at risk

ARTICLE IV.

This corporation is to exist perpetually. The manner in which the Directors are elected or appointed is set forth in the Bylaws of **CULTIVAMOS UNA ROSA BLANCA, INC.**

ARTICLE V.

The street address of the principal office of this corporation is 1820 East Hallandale Beach Boulevard, Hallandale Beach, Florida and the name of the initial registered agent of this corporation is **MARK PERLMAN**. The corporation may have such other places of business, both within and without the State of Florida, and in foreign countries, as may be necessary or convenient.

ARTICLE VI.

Officers of the corporation will be selected and appointed by the initial Directors of the corporation based on their commitment to promote the cause of human rights.

ARTICLE VII.

The Board of Directors of this corporation shall consist of not less than two (2) members, initially. The number may be increased from time to time, but shall never be less than two (2) members.

ARTICLE VIII.

The names and addresses of the Members and Directors of the corporation and shall hold office as directors during the first year of the corporation's existence, or until their successors are elected and qualified, are:

ARTICLE IX.

The management and control of the business of the corporation shall be conducted under the direction of the Board of Directors by the following officers who shall be elected by the Board of Directors, to wit: a President, one or more Vice Presidents, a Treasurer and an Assistant Secretary, and one or more Assistant Secretaries, provided that any one or more of said officers

may be held by the Secretary or Assistant Secretary of the corporation. The Secretary or Assistant Secretary may not also be the President.

ARTICLE X.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, to intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to and candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on 9(a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or (b) by a corporation, contribution to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except in an insubstantial degree, engage in any activated or exercise any powers that are not in furtherance of the purposes of this corporation

Under the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets or so disposed of shall be disposed of by a Court of competent jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XI

In compliance with Section 48.091, Florida Statutes, the following is submitted: First, that **CULTIVAMOS UNA ROSA BLANCA, INC.**, desiring to organize or qualify under the laws of the State of Florida, with principal place of business in the City Hallandale Beach, State of has named **MARK PERLMAN**, located at 1820 East Hallandale Beach Boulevard, City of Hallandale Beach, State of Florida, as its agent to accept service of process within Florida.

Having been named to accept service of process for the above stated corporation, at the place designated, I hereby agree to act in this capacity, and I further agree to comply with the provisions of all statutes relative to the proper and complete performance of my duties.

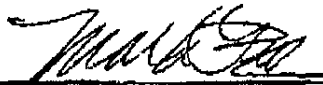

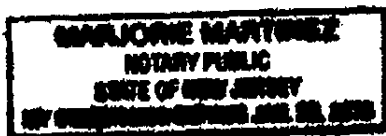

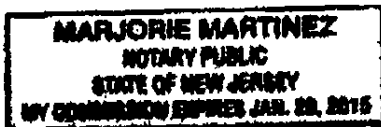
