Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of , do hereby certify:

First: The name of the Corporation shall be KEYSTONE CLOUDBUSTERS Inc.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Keystone Heights, Clay County, Florida

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for the education, use and enjoyment of Radio Controlled Model Aircraft. such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."
