**NONPROFIT ARTICLES OF INCORPORATION
OF**

CHRISTIAN FAMILY CENTER OF ST. CLOUD, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, section 617, Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be as follows:

CHRISTIAN FAMILY CENTER OF ST. CLOUD, INC.

ARTICLE II - EXISTENCE

The Non-For Profit Corporation shall have perpetual existence.

ARTICLE III - PRINCIPAL OFFICE

The principal office of the Corporation shall be:

ARTICLE IV - PURPOSES AND OBJECTIVES

The specific purposes for which the Non-for-Profit Corporation is organized are:

A. To organize and operate exclusively as a non-for-profit Corporation, a Christian Church to minister and to preach the Word of God (The Gospel) to the general public. To receive donations of any kind in any lawful manner from the general public.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to its members' trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of the organization shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purposes.

B. To organize and operate charitable funds for the needy and fosters and senior citizens.

C. To develop and organize Christian educational organizations at different levels to the general public.

D. To sell, distribute, purchase or acquire in any lawful manner Christian literature and music in the form of book, tape, disk, cassette, compact disk, or in any other possible form.

E. To give and participate in Christian crusades, television and radio programs and live concerts around the world.

F. To invest the funds of this corporation in real estate, mortgages, or any other type of investment, and to own real and personal properties that are necessary to carry on the organization purposes.

G. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objectives or the furthermore of any of the purposes enumerated in these Articles of Incorporation or any amendment hereof necessary and incidental to the protection and benefit of the corporation, and, in general, either alone or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes and objectives of this corporation.

H. The foregoing paragraphs shall be construed as enumerating both objectives and purposes of this nonprofit corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

ARTICLE V - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected shall be stated in the By Laws of the corporation.


ARTICLES IX - ARTICLES OF INCORPORATION



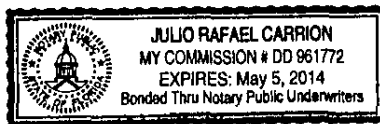
