ARTICLES OF INCORPORATION

Sistahs 2 Sister Inc.

A Nonprofit Organization in the State of Florida

Article I:

The name of the corporation is Sistahs 2 Sister Inc.

Article II

Article III

The specific purpose or purposes for which the corporation is exclusively for charitable, religious, and educational: scientific purposes, including, for such purposes, the making of, distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII

DISILLUSIONMENT

Upon the disillusionment of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to the state or local government for the use of public purpose. Any such assets not disposed of by the court of jurisdiction of Harris/Galveston Counties or other counties where the corporation will conduct business exclusively for such purposes or to such organization or organizations, as said court of jurisdiction shall determine, which are organized and operated exclusively for nonprofit charitable purposes.

Article IX

CONFLICT OF INTEREST

Board Member of the Sistahs 2 Sister Inc. must insure balance, independence and objectivity. All Board Members in a sponsored activity are expected to disclose to activity audience and significant financial interest or other relationship (1) with the setting of salaries of any paid staff members and/or provider(s) of commercial services discussed. (2) With any commercial supporters of the activity. (Significant financial interest or other relationships can include such things as grant support, employee, consultant, members of other organizations etc...) The intent of this disclosure is not to prevent any member of the board to have direct or indirect interest with any significant financial or other relationship set for with the corporation. It remains for the Board of Directors to determine whether the interests or relationships may influence the decisions with regard to his declaration of conflict of interest.

Article X

WHISTLEBLOWERS ACT

Sistahs 2 Sister Inc. expects its members, directors, officers, employees, contractors, and other representatives to observe high standards of business and personal ethics in the conduct of their duties and responsibilities. All employees and representatives of Sistahs 2 Sister Inc., must practice honesty and integrity in fulfilling their responsibilities and comply with all applicable laws and regulations. It is the responsibility of all members, directors, officers, contractors, and employees to report Wrongful Conduct in accordance with this Whistleblower Policy.

Article XI

PRIVATE INUREMENT

Sistahs 2 Sister Inc., exist for the public good and not to be created or operated for the benefit, financial or otherwise, of a private individual. Violation of these doctrines can result in heavy taxation and/or loss of nonprofit status.
