Resolved that any Salaries, Wages, together with fringe benefits or other form Compensation (housing, transportation or other allowances) paid to provide for employees directors or officers will not exceed a value <sup>which</sup> is reasonable and commensurate with the duties and working hours associated with such employment and the compensation ordinarily paid persons with similar positions or duties.
