

**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF  
THE WAY COMMUNITY CHURCH, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, The undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**AMENDED ARTICLE III – PURPOSE OF THE CORPORATION**

**CHANGED TO READ**

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific Purpose(s) are: The specific objectives and purposes of the organization shall be to live and spread the established, historic, Biblical Christian faith (Matthew 22:37-39, 28:19-20) in accordance with the policies and guidelines of the Board of Directors. Further, it is the express purpose of this organization to minister the Word of God to the faithful (Acts 6:4) to conduct regular services through various forms of ministries, and to promote and encourage those that are in need through the various ministries of the organization (I Thessalonians 5:11, James 1:27); to cooperate with other organizations and institutions in ministering God's Word (I Corinthians 1:10; Ephesians 4:4) to spread the Gospel of Jesus Christ by ministering through seminars, media, literature, and other forms of communication (Romans 10:15; 1 Corinthians 9:12, 18-19); and to do any and all other things and activities which will serve to promote the Gospel of Jesus Christ under the direction of the Holy Spirit, and in accordance with the provisions set forth in the Scriptures, the Holy Bible (2 Timothy 3:16-17, 2 Peter 1:20-21).

**AMENDED ARTICLE XIII DISSOLUTION**


**CHANGED TO READ**

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the country in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

On motion and by unanimous vote by the board of directors, the preceding articles of amendment of THE WAY COMMUNITY CHURCH, INC. were adopted. There are no members or members entitled to vote on the amendments.
