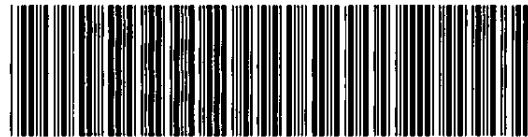

We, the undersigned, do hereby associate ourselves together for the purpose of forming a body corporate, under the laws of the State of Florida, and by and under the provisions of chapter 617 Florida Statute providing for the formation, liabilities rights and immunities of a corporation not for profit and hereby adopt all the articles of incorporations.

Article I

The name of the corporation shall be: New Covenant Bible Baptist Fellowship, Inc.

Article II

Purpose and Members Qualifications

Religious activities such as worship service and all the other church functions.

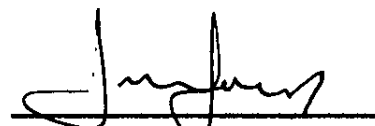

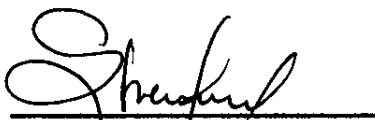
No part of net earnings of the corporation shall inure to the benefit of any individual or member.

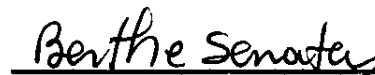

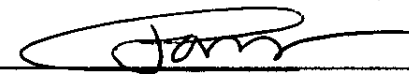

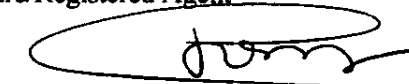
