ARTICLE I
NAME AND RESIDENT ADDRESS

ARTICLE II
PURPOSE

The purpose for which the Corporation is organized is to promote and advance in all lawful ways the mutual interests of its members engaged in providing charitable and/or humanitarian assistance toward American Veteran Amputees, their physical, mental and spiritual rehabilitation, their integration back into society and family, and to provide assistance with health professionals and peer support through all phases of rehabilitation. The Organization shall disseminate all types of information to improve the quality of the standard of care for amputees in general, and all other lawful activities authorized by the State of Florida.

ARTICLE III
QUALIFICATION OF MEMBERS

Member Qualifications: All Regular and Associate Members who are American veterans must prove that they were honorably discharged at the end of their last period of military service.

Regular Member: Must be an American Veteran amputee.

Associate Member: Any person, representative of education, government, business, or industry; or any firm, corporation, or association directly or indirectly interested in the well being of amputee American Veterans, whose application for membership shall have been approved by the Board of Directors.

**ARTICLE IV
DURATION**

The term of the Corporation shall be perpetual.
