

1. The date on which the Corporation was first formed was October 30, 1992.

For administrative purposes, Articles of Merger have been approved for filing in the District of Columbia as evidence of the domestication of the Corporation in the State of Florida as dissolution documents were not appropriate for the change in jurisdiction.
3. The name of the Corporation immediately prior to the filing of this Certificate of Domestication was National Center for Prevention and Research Solutions, Inc.
4. The name of the Corporation as set forth in its Articles of Incorporation, to be filed pursuant to §§617.01201 and 617.0202 with this certificate, is National Center for Prevention and Research Solutions, Inc.
5. The jurisdiction that constituted the seat, siege social, or principal place of business or central administration of the Corporation or any other equivalent jurisdiction under applicable law, immediately before the filing of this Certificate of Domestication, was the District of Columbia.

ARTICLES OF INCORPORATION  
OF  
NATIONAL CENTER FOR PREVENTION AND RESEARCH SOLUTIONS, INC.  
a Florida not-for-profit corporation

ARTICLE 1.

NAME

The name of this Corporation shall be: National Center for Prevention and Research Solutions, Inc.

ARTICLE 2.

DURATION

The duration of this Corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE 3.

PURPOSE

The purposes of the Corporation shall be exclusively charitable in nature, to-wit: To engage exclusively in activities for charitable, religious, or educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), and within these restrictions, to engage in activities including but not limited to research and development of educational material and to promote the welfare of youth through educational and other programs related to, among other things, preventing substance abuse, promoting life skills, and fire safety.

ARTICLE 4.

DISSOLUTION

Upon the dissolution of the Corporation the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), as the Board of Directors shall determine.




