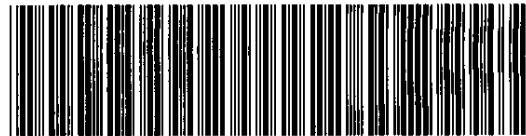

In Compliance with Chapter 617, F.S., (Not for Profit)

***ARTICLE I***  
***NAME***

***PURPOSE***




