ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S. (Not for Profit)

Article I: Name - Deaf Children and Families Connection, Inc.

Article II: Principal place of business and mailing address of the corporation.

Tallahassee, Florida 32312-1231

Article III: Purposes for which the corporation is organized.

Deaf Children and Families Connection (DCAF) is organized as a not for profit corporation under the laws of the State of Florida to engage in charitable and educational activities that promote, support, assist, and foster a better quality of life for children and adults who are deaf, hard of hearing or otherwise hearing impaired, regardless of age, race, national origin, gender or religion.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IV: Earnings of the Corporation.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

Article V: Dissolution.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article VI: Election of Directors.

The manner in which the Directors are elected or appointed will be as set forth in the Bylaws.

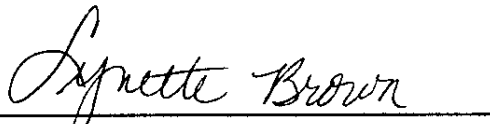
